Reacting to changes in customer demand for products distributed through GSA's Federal Supply Service distribution operations, we will be consolidating our activities. The purpose of this letter is to assure you that GSA will continue to provide the high level of service you require. In fact, as part of this effort, we will be focusing on ways to improve our service and leverage new market opportunities. The specific details are as follows:

We will be consolidating our distribution operations in two centers located in Burlington, New Jersey and Stockton, California and closing our Palmetto, Georgia and Ft. Worth, Texas Centers. We also will be closing our Forward Supply Points, which are satellite distribution sites, located in Franconia, Virginia, Chicago, Illinois, Denver, Colorado, and Auburn, Washington. We expect these facilities to close during the next fiscal year.

There will be no change in our ordering procedures. Our valued partnerships with the JWOD program, NIB and NISH, will, of course, continue.
